- ◆ Admission will be given in accordance with the circular of education department.
- ◆ Desirous students for taking admission in (Common/Science stream) should have passed S.S.C. Examination with Science, Maths and English Subjects.
- ◆ Filled up Forms will be accepted from the next day of the S.S.C. result.
- ◆ Along with admission form students should submit Aadhaar Card copy, Photo Copy of L.C., 10th Marksheet and passport size photograph.
- ◆ Original L.C. will have to be submitted along with admission fee which will not be returned. So it is requested that the students should keep extra copies with them.
- ◆ Incomplete form will be rejected.
- ◆ Fee will be accepted in cash or by cheque. If the cheque is bounced, the charge will be paid by parents.
- ◆ The school is authorised to cancel/reject any admission form.
- ◆ No correspondence through letter regarding admission will be done.
- ◆ Admission Fees is to be paid as per merit in school office within notice period.
- ◆ Payment of school fees should be paid before time otherwise late fees would be charged.
- ◆ **Fees will not be refunded or transferred to any other person on cancellation of the admission.**
- ◆ Date of the commencement of the regular classes will be displayed on the notice board and regular teaching will be started from very first day.
- ◆ Students are has required to keep their identity card issued by school to them.
- ◆ Regularity, attendance and obedience are required.
- ◆ Without prior permission if a student remains absent or does not wear uniform or leaves class or misbehaves or does not bring books and required materials or does harm to school property and who challenges the established values of the institute, will be dismissed from the school and be given a bad conduct certificate.
- ◆ Students are required to remain present in all the examination conducted by the school.
- ◆ 80% attendance and satisfactory internal work is compulsory for Board Examination otherwise Board Examination form will be withdrawn.
- ◆ Student can contact their class teacher and if necessary to the Principal and last to the Co-ordinator for their problem without any hesitation regarding school matters.
- ◆ Parents / Guardian are requested to contact the school authorities from time to time to know the progress of their ward.
- ◆ In case of absence, the student must come with leave note of parent's signature.
- ◆ The use of mobile phone is strictly prohibited in the school premises. If the students, found violating the instructions would be liable to the punishment upto the cancellation of the school admission.
