RULES & REGULATIONS

- Along with admission form students should submit Photo Copy of L.C., 8th Marksheet and passport size photograph.
- Incomplete form will be rejected.
- Any admission form can be cancelled or rejected without giving any clarification.
- No correspondence through letter regarding admission will be done.
- Fees are to be paid within notice period.
- Monthly, half yearly and yearly fees can be paid in school office otherwise late fees would be charged.
- Original L.C. will have to be submitted along with fees which will not be returned. So it is requested that the students should keep extra copies with them.
- Date of the commencement of the regular classes will be displayed on the notice board and regular teaching will be started from very first day.
- Student desirous of taking admission in Std. 9th should have passed Std. 8th Examination.
- Personal Coaching will not be encouraged.
- Uniform is compulsory :

<u>For Boys :</u> Half sleeve shirt of light grey colour checks , pent of alcium grey with neck tie & Black Leather Boot, Black Belt.

<u>For Girls :</u> Half sleeve shirt of light grey colour checks, skirt of alcium grey with neck tie, Black payzama & Black Leather Boot.

- Fees will not be refunded or transferred to any other person on cancellation of the admission.
- Students are required to keep their identity card issued by school with them during the school hours.
- Regularity, attendance and obedience are required.
- Without prior permission if a student remains absent or does not wear uniform or leaves class or misbehaves or does not bring books and required materials or does harm to school property and who challanges the established values of the institute, will be dismissed from the school and be given a bad conduct certificate.
- Students are required to remain present in all the examination conducted by the school.
- 80% attendance and satisfactory internal work is compulsary for Annual / Board examination otherwise Annual / Board examination form will be withdrawn without any prior notice.
- Student can contact their class teacher and if nacessary to the Principal and last to the Co-ordinator for their problem without any hesitation.

- Parents / Guardian are requested to contact the school authorities from time to time to know the progress of their ward.
- In case of absence, the student must come with leave note of parent's signature.
- The use of mobile phone is prohibited in the school premises. The students found violating the instructions would be liable to the punishment upto the cancellation of the school admission.
- Planning book regarding list of holidays, syllabus, marks etc. will be given in the class room.
- If the student does not show progress in studies, inspite of being given four chances, he/she will be terminated without any further notice.
- If the student leaves the school in the middle of the year he/she has to pay a full year fees as well as scholarship fees amount, After that, L. C. will be issued.
- The Caution Money Amount Rs. 1000/- will be given to student after completing Std. 10th Studies, only showing original receipt with the time limit of six month after completing their studies.
